The Deanship of Student Affairs at the University held yesterday, Sunday, 10/5/1444 AH, the "Pioneers for Persons with Disabilities" program, in conjunction with the International Day of Persons with Disabilities, where the program included organizing several events that included an exhibition, workshops and consultations, in the main lobby of the university city, in the presence of His Excellency the Vice President for Educational Affairs, Dr. Muhammad Al-Sharekh.



The exhibition reviewed the Kingdom's efforts in supporting persons with disabilities, and the university's efforts in this field by preparing the infrastructure and facilitating this category of society to obtain their services, as the university established a permanent committee for the care of persons with disabilities, in addition to guidance and guidance support for them, and coordination with colleges and deanships to provide the necessary support to serve these students, guidance and academic support, as well as facilitating communication with entities outside the university.

The role of the Standing Committee for the Care of Persons with Disabilities at the university was also reviewed, which specializes in considering the social and psychological problems and study they face, and helping them find appropriate solutions to them, as well as creating opportunities for them to express their talents and develop their abilities to enable them to make appropriate decisions, in addition to supervising the transfer of severe cases to the competent authorities and determining the necessary projects for infrastructure equipment at the university in a manner commensurate with people with disabilities, as well as activities and programs for persons with disabilities through participation in various Events.

It is noteworthy that the number of students with disabilities studying at the university is 272 students in various colleges, including 150 students with motor disabilities, 86 students with visual disabilities, in addition to 36 students with hearing disabilities.

The University, represented by the Deanship of Student Affairs, organized several scientific meetings within the virtual program held on the occasion of the International Day of Persons with Disabilities entitled "Himmam", in cooperation with the Department of Special Education at the College of Education, on Thursday, 18/4/1442 AH, where the program contained several virtual meetings that dealt with many aspects of the academic life of students of determination, and reviewed some of their university experiences



and academic excellence in successfully passing the university stage.

The first meeting was held under the title "People with Disabilities in the University Environment", and was presented by Dr. Muhammad Al-Ajlan, Chairman of the Standing Committee for the Care of Persons with Disabilities at the University, Dean of the Deanship of Student Affairs, and Dr. Muhammad Al-Obaid, member of the Committee, and Head of the Department of Special Education, where the meeting discussed a number of axes, including: preparation in the university environment, educational auxiliary services, and support services.

While the second meeting, which was held under the title "Student Lights" with a group of university students with disabilities, dealt with a number of axes, namely: the experiences of students with disabilities at the university, (deaf, people with motor disabilities, and the blind).

The third and final meeting was held under the title "Global Trends on Disability", and was presented by Dr. Theeb Al-Mutairi, Associate Professor of Special Education at the Department of Special Education, in which he spoke about universal access, support and inclusion for persons with disabilities.

The College of Education, represented by the Department of Special Education, carried out an awareness and educational campaign under the slogan "With you and with you", last Thursday, which was opened by Dr. Ali Al-Saif, Vice President for Educational Affairs, at the Othaim Mall complex in Buraidah, with the aim of educating the community



about the special educational and rehabilitation programs used with individuals with special needs, where the participants in the campaign educated visitors about these programs, in addition to how to support this category in all fields, especially in education, training and employment, and introduce the community to them, and promote the concept of integrating people with Special needs in society, encouraging them to trust themselves and their abilities on the one hand, and developing the capabilities of those working with individuals with special needs on the other hand.

The campaign also included several pillars, including: a corner on autism disorder, a corner for giftedness and excellence, a corner for learning difficulties, a corner for mental disability, speech and speech disorders, and visual disability, where each corner included the definition of the concept it expresses, causes, characteristics, diagnosis, training and treatment programs, in addition to instructions for parents on how to deal with people with special needs, as well as a special corner to provide consultations for mothers with special needs, in the presence of blind students from the Department of Education who presented some work to the attendees.

The study, prepared by Dr. Youssef Al-Dabasi, a faculty member at the university, and presented its results during the "Community Eye Health" symposium held yesterday, Sunday, by the Department of

Optometry at the College of Applied Medical Sciences at the university, revealed the high prevalence of visual defects in more than 20 schools in the city of Buraidah and the rest of the governorates of Qassim, after signing the medical examination on the eyes of children for more than 5000 students, where it was found that the prevalence of visual defects is 18% among male and female students and the prevalence of uncorrected visual defects 16%, indicating that this rate is very high when compared to studies in the rest of the world as well as the prevalence of lazy eye 4%.

To treat these vision problems, Dr. Seif El-Din Rashid, a faculty member in the Department of Optometry, presented his research paper in which he presented the treatment plan for eye diseases in developing countries, where the study worked on developing a comprehensive plan for the prevention and treatment of eye diseases, and concluded that the problems of uncorrected refractive defects are the first cause of visual disability among school students.

The symposium sessions, which were held under the patronage of His Excellency Prof. Dr. Abdul Rahman bin Hamad Al-Dawood, President of the University, and with the participation of 12 speakers from inside and outside the university, discussed a number of important topics related to eye health and safety, at the headquarters of Hall "B" in the main lobby of the University City, in conjunction with the World Sight Day, which falls on October 10 of each year.

Dr. Sulaiman Al-Dakhil, a faculty member at the college, participated in the symposium with his research paper on the control of myopia, which is one of the most common visual disorders around the world, pointing to the growing concern that existed about the increase in the prevalence of myopia during the past half century, as both genetic and environmental factors play an important role in the growth process in the human eye, and many studies have shown the impact of environmental factors, specifically reading, on the onset of myopia.

Dr. Majid Maafa, Director of Optometry Clinics, presented through his research paper statistics on the visit of optometry clinics to 57 primary schools in the Qassim region, during which 10,879 students were examined, and 1,309 students were followed up in university optometry clinics who were discovered to have vision problems and need medical follow-up, and he also pointed out that during the past year, the service was provided to five thousand beneficiaries through all various community service programs.

Regarding glaucoma, the hidden threat, Dr. Muhammad Al-Luwaimi, a faculty member at the college, stressed that glaucoma is a chronic eye disease, and is defined as a group of chronic disorders leading to blindness, as it cannot be treated, but the rest of the eyesight is preserved after the disease, and glaucoma poses a threat to community health as it is one of the diseases that are difficult to diagnose and are in advanced stages when discovered.

In turn, Dr. Manzoor Qureshi answered the question of why do we care to examine the retina? He said: Detecting retinal problems early helps prevent vision loss, especially since vision lost due to retinal problems may never return, and periodic examination of the retina helps to start treatment in a timely manner before vision loss.

For his part, Dr. "Vishach Nair" spoke about diabetic retinopathy, which is a complication of the small blood vessels, which is a feature of both type I and II diabetes, while Dr. "Goodwin Offenseri" spoke about severe visual impairment, noting that globally nearly 1.3 billion people live with a form of visual impairment and with regard to remote vision, and there are 188.5 million people with moderate vision impairment, 217 million have severe vision impairment, 36 million people are blind, and in terms of near vision, 826 million livep suffer from proximal visual impairment.

Globally, the main causes of visual impairment are refractive errors and cataracts, nearly 80% of all visual impairment globally are avoidable, and the majority of people with visual impairment are over the age of 50.

After that, Dr. Walid Al-Ghamdi, Head of the Optometry Department at the University, spoke in his paper entitled Challenges and Aspirations for Community Eye Health, during which he presented an overview of community eye health in the Kingdom and its position in combating blindness and visual impairment globally, as well as the necessary priorities to improve eye health and control high rates of visual impairment.

Dr. Shahzad Naro, visiting professor from Aston University, UK, also spoke about the impact of lifestyle on eye health and unhealthy habits that have a direct impact on eye health such as poor nutrition and smoking, as the study concluded that smoking has a direct impact on the eye, especially in the outer part of the eye, and in the tear layer that works to protect the eye, and also smoking has an impact on the strength of the eye's adaptation, and the study recommended educating the community about the impact of smoking on the eye, as well as taking the amount of Enough foods containing omega-3.

While Dr. Yahya Abu Haidar, National Coordinator of the National Committee to Combat Blindness (Lamaa), spoke in his paper entitled Strategies to Combat Blindness in the Kingdom of Saudi Arabia, about the establishment of the National Committee to Combat Blindness and its role in society, and about charities related to blindness and their role in supporting the blind, and also talked about the national indicators to combat blindness issued by the World Health Organization and the need to develop plans for their implementation, in addition to the role of all government and private agencies in implementing the eye health strategy in the Kingdom.

The community eye health symposium concluded by issuing some recommendations, including: activating primary eye health care where support and tools are available for this work, as well as giving optometrists and optometrists their full role in the health system so that they can carry out their work more effectively, especially in primary care centers, in addition to redistributing the number of optometrists to hospitals and health centers in proportion to the number of patients and visitors to each health facility, and activating screening programs and campaigns for chronic eye diseases. Which in turn reduces the value of treatment and improves the quality of life, which is one of the most important goals of Vision 2030.

The participants also stressed the importance of developing a long-term plan for the workforce that attempts to link the outputs of educational and training systems with the needs of the labor market in the Kingdom within the framework of a development plan that achieves alignment between education and training policies and policies of Saudization, while activating the National Observatory of Statistics in order to create a wide database, provided that the General Statistics and Information Authority becomes the official body in issuing official data on the labor market.

As part of its contribution to solving many of the obstacles faced by women in order to learn to drive, the university continues to carry out construction work to establish a driving school for women within the university city of Al-Meida, within the framework of the plan set and the specified timings, where the design was completed, the introduction of a brochure of the conditions and specifications of construction, and the design of training fields to mimic the best international practices to qualify female driving trainees.

His Excellency Prof. Dr. Abdulrahman bin Hamad Al-Daoud, Rector of Qassim University, directed the establishment of a university-owned institution that establishes, operates and manages a driving school for women, following the signing of an agreement between the university and the Kingdom's Traffic Department to establish the school.

This step comes within the University's efforts to achieve the fourth strategic goal, which is to serve issues related to women and the family, because of its positive social and economic results, especially since this service will contribute to achieving ease of movement and mobility for women, to reach their work or place of education.

The General Supervisor of the Establishment of the Driving School, Dr. Majid Al-Anzi, confirmed that the agreement with the Traffic Department provided for the establishment of the school and its operation within 6 months, where work is under way to establish the building with a total area of 1800

meters, and the designs of the training fields, which are estimated at about 30,000 square meters and contain 18 traffic skills, have been completed.

Al-Enazi pointed out that the school will be provided with the best driving simulators dedicated to simulating the traffic driving experience, where simulation lessons will be provided using a device that simulates the driving of the real car, and consists of all the parts that make up it inside the car such as the driver's seat, steering wheel, control panel, power key, and seat belt and surrounds the passenger with screens that display interactive virtual reality that simulates a large number of scenarios that the driver may be exposed to under conditions Different air and geography and the device gives its instructions to the passenger interactively and shows the commander the mistakes he has made.

Al-Enazi added that the location of the school was chosen to be on campus in order to take advantage of the internal roads of the campus and use them in the future to train trainees in a safe environment, as the university intends to attract certified driving trainers from official bodies to practice the activity in order to provide the best services to the trainees, where the university emphasizes its keenness to apply the best international specifications for driving schools and provide distinctive and accredited training programs.

The international students are divided into two types:

- International students live in the kingdom with official Ikama
- International students from outside the Kingdom and have educational grants

Qassim University cares for both types of international students, and established many units and vice-deanships to guide and help them.

These are demonstrated as follows:

• Grant Unit in the Deanship of Student Affairs.

This unit looks after the receiving the applications for studying in the University, issuing the visa from the responsible body, After students are officially admitted to the University, the Unit receives them, arranges for their subsistence and accommodation in the University housing, and provide the social care for them, organizes the educational environment and the suitable medical care and whatever helps them to be familiar with the University atmosphere.

• Unit of Teaching the Arabic Language or non-Arabic speakers in College of Arabic Language and Social Studies.

It cares for the international students and offer Arabic Language Diploma as a second language. During this Diploma, they practise listening, conversation, reading and writing in multilateral Arabic language.

• Vice-Deanship of Admission and Registration for grants student affairs, which care

for:

1- Activating mechanisms of attracting the distinguished international students. The university used to form committees from the faculty to attract the international students from their countries and meet them as it is keen to attract the talented and creative students. The University found that it enough to use the Admission Gate of the Higher Education Ministry and nominating the students through the Saudi Culture Councils as governed by the related regulations regarding the admission of the non-Saudi grant students in the Saudi higher education in the Kingdom. The University cooperates with the Islamic centers all around the universe, which nominate students for joining the University.

Thereafter, the University investigates their files to check their experiences, skills, grades and validity to join the University.

- 2- Application of the rules of admission of the international students as per the regulations of admitting the non-Saudi grant students in the Saudi higher education in the Kingdom.
- 3- The processes of admission of the students, registration, issuing the academic numbers and IDs of the international students.
- 4- Following up the academic status and progress of the international students.

The University presents the supporting programs for the international students to get them familiar with the University society and Al-Qassim region through the Orientation and Guidance Directorate in the Deanship of Student Affairs, preparation programs for new students, and Academic Advising and Orientation units in the colleges. It follows up their academic grades and progress, and checks the satisfaction of graduation requirements through the electronic system in the Admission and Registration Deanship.

Also, the University provide the social and free medical care through the Medical Services Directorate of the University. it periodically explores their opinion and the level of satisfaction about the University services offered to them.

Female Student Transport Unit

It organizes and supervises the transfer of female students. The unit provides public .and private transportation for them The unit also performs the necessary screening for the selection of drivers by examining the CVs of the drivers and determining the validity of the buses to work or not, according to the criteria set by the unit, and included in the contract with the transport contractor at the university. The unit also registers female students wishing to benefit from the transport service, and issue drivers 'data cards and student cards using the public transport service, which contains the student's name and the vehicle number assigned to it, as well as issuing lists of students' names for each bus, to facilitate dealing with them.

- 6- Introducing students to the Kingdom and the scientific, economic, political, social and health renaissance it is witnessing.

Third: Admission Requirements:

- 1- Internal and external scholarship students shall be subject to the admission requirements applicable to Saudis in higher education institutions.
- 2- The admission of students of external scholarships requires the following: a. The age of the student shall not be less than (17) years and not more than (25) years for the undergraduate stage and the Institute of Teaching Arabic Language or its equivalent, (30) years for the master's degree, (35) years for the doctoral stage, and the Council of the educational institution may make an exception from that.
- In. The student allowance government must approve the study in the Kingdom for countries that require this for Saudi students .
- c. The student should not have received another scholarship from one of the educational institutions in the Kingdom.
- W. Certificates and identification papers must be certified by the competent authorities determined by the educational institution.
- C. To bring a certificate free of precedents from the security services in his country. Going to. Not to be dismissed from one of the educational institutions in the Kingdom. X. The student must be with a mahram, in accordance with the instructions regulating this, provided that he is covered by a scholarship, has a regular residence, or submits to the register of an employer in need of his services.
- D. To pass the medical examination prescribed by the regulations and instructions.
- 3- The Council of the educational institution shall set the executive rules governing the admission of scholarship students from within, taking into account the following:
- a. The student must obtain the approval of the person who has his record to study in the educational institution.
- In. The student must be a regular resident in the Kingdom.

Fifth: Submission of grant applications:

- a. The Kingdom's embassies and representations abroad.
- In. Higher education institutions in the Kingdom.

Sixth: Procedures for accepting scholarship students:

- 1- The Kingdom's embassies and representations abroad shall receive scholarship applications submitted to them in accordance with the principles approved by the Standing Committee formed in the Ministry of Higher Education, and after verifying those applications, the Ministry of Foreign Affairs shall refer them to higher education, provided that this is within the specified periods, and applications for admission will not be accepted, as agreed upon in the Standing Committee.
- 2- The Ministry of Higher Education refers the names of students nominated for study to the Ministry of Foreign Affairs, to complete the initially accepted students by reviewing the Kingdom's representations in their countries to complete the visa procedures.
- 3- In the event that scholarship applications are received from abroad to higher education institutions in the Kingdom, the Ministry of Higher Education, after fulfilling the conditions prescribed by law, sends the names of the nominated students to the concerned authorities and the Ministry of Foreign Affairs and takes measures in accepting them.

Seventh: Advantages of scholarships.

- a. Health care for him and his family members if he settlesSustain them to stay with him which is provided to citizens, and provided by the educational institution if the regulations so require |. In. Payment of a two-month reward for processing upon arrival.
- c. Payment of a three-month graduation allowance for shipping books.
- W. The advantages enjoyed by his counterparts from the students of the educational institution.
- C. Treating the scholarship student who is regular in the Institute for Teaching Arabic to Non-Native Speakers in financial benefits as university students from his counterparts in theoretical disciplines. Going to. The educational institution provides him with reduced diets.
- X. Providing housing and appropriate scientific, social, cultural and training care.
- D. Disbursement of tickets stipulated in the financial regulations of the educational institution and the educational institution may compensate him with their value if submitted at his expense, provided that the compensation does not exceed the value of the ticket paid to his colleagues from the same country.
