His Excellency the Minister of Education blessed this agreement, wishing Saudi universities success in order to contribute to building the human being of this generous country.

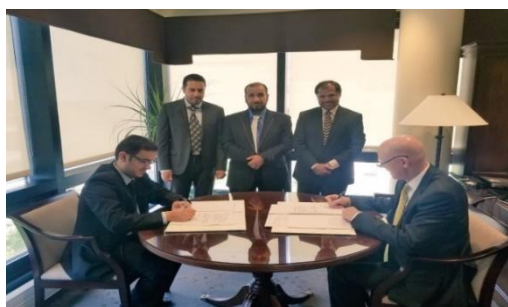
